Letter mailed to bank voting stockholders announcing Nominating Committee's recommended slate of qualified candidates

45-Day Period after
Stockholder Letter is
Mailed

Individuals may petition to be included as a candidate on the ballot

After Conclusion of
Petition Period (on or
about July 15, 2020)

Election ballots mailed; Farm Credit Affiliated Associations may begin caucusing

Approximately 60 Days
after Mailing of Ballots

Election ballots due back to Independent Teller
